

Environmental policy

RODA S.r.l. offers its experience, innovation, research, expertise, and experimentation in the production of outdoor tables, chairs, armchairs, and sofas.

The use of resistant, recycled, recyclable, non-toxic, hypoallergenic, and certified components is a concrete part of the company's environmental responsibility. These include teak, the fundamental essence of many RODA products, which for some collections is offered 100% FSC®, coming from controlled forests. Straps, fabrics, and lanyards are regenerated from the recovery of production materials through a process that reduces the use of water and chemical additives and emits less CO2. Aluminium, increasingly used by the company, combines lightness and sustainability, it is a material that can be recycled indefinitely, while 100% natural brown cork is obtained from a production with a completely green energy impact.

Most of RODA's products have obtained the GREENGUARD GOLD, an important international certification that recognizes compliance with the strictest existing criteria in terms of low emissions for people's health. RODA has also obtained FSC-C155819 FSC® (Forest Stewardship Council®) certification, the brand of responsible forest management, for the role it plays in protecting the ecosystems from which the material of choice for outdoor furniture comes: teak wood. These certifications testify to the choices and commitments that RODA pursues, communicates, and shares with responsibility and pride.

RODA S.r.l. has two sites, the management, sales, and administration activities are carried out in the Gavirate (VA) headquarters; while the assembly and logistics activities at the Bodio Lomnago (VA) site.

This document defines the "Environmental Policy" that RODA S.r.l. intends to pursue, in coherence with and in compliance with the objectives set by the Management.
